

DEMONSTRATION/COURTESY/LOAN VEHICLE INDEMNITY TERMS AND CONDITIONS

Important – Restrictions apply (any queries phone Wilby Insurance on 01422 358525)

- **Min age:** Riders of between 18-25 years of age and all riders with less than 1 full years experience from passing their motorcycle riding test can be accompanied if required. **You must inform us if you have a restricted license.** **Max age:** None.
- Persons on restricted licenses (for any reason) must be referred to our underwriter.
- Any person who has had motor insurance declined or terms imposed and cover cancelled will have to be referred to our underwriter.

Unfortunately due to a number of accidents involving our machines either loaned or on demonstration **we have to insist that you agree to one of the following conditions below (either A or B) before taking control of any vehicle we provide, own or in the care of Woods Motorcycles. You must deposit a vehicle and keys with us as security in all cases.**

THEN PLEASE CHOOSE EITHER A OR B BELOW:

A. That you have taken out **fully comprehensive insurance cover** showing the correct details of the vehicle, make, model and registration number etc (a photocopy of the original cover note will be taken) that you wish to ride. **NOTE:** Woods motorcycle can provide you **with fully comprehensive insurance at a cost of £59 per person, per day with an excess of £975 for any claim, which is payable by yourself in advance.**

OR

B. If you **cannot (or don't wish to) provide fully comprehensive insurance** for the vehicle, we require you to sign a declaration and provide your full name, address and telephone number, stating that you **are fully aware that should any damage be caused by yourself or any other person to the vehicle whilst in your care, you will be solely responsible for covering any costs of repair and/or any claims from a third party.** Payment will be due immediately after production of a detailed invoice for the necessary repairs to put the machine back to its pre accident condition, including parts (new parts will be used), labour and consumables. The price of the parts and labour required will be charged at retail + V.A.T where necessary. **Please note, your deposited vehicle will be kept by us for security of payment as well as your license and passport or any other security left by you until full and final settlement for any damage caused is provided and paid.**

In addition I agree to and fully understand the below terms and conditions.

C. **I agree to be liable for the cost of replacing the vehicle at retail value, if whilst in my care or possession the vehicle is stolen, I further agree to be liable for any recovery or estimate charges imposed by Woods Motorcycles.** I understand and agree that it is my responsibility to **store the vehicle in a locked garage over night, or when not in use.** I also agree to **lock it securely with a Thatcham approved chain & padlock whilst parked anywhere in my possession.**

D. **I will return the vehicle on or before or by such day that may be specified by prior written notice to me.** If I keep the vehicle past the above date I agree to pay **£75+VAT** (excluding insurance costs and excess) per day for the loan cost of the vehicle. I am also responsible for arranging and maintaining at my expense, comprehensive insurance cover for the motorcycle whilst it is in my possession and agree to pay the dealer any excess under that insurance policy.

E. I agree to keep and maintain the vehicle at my expense and in good condition and repair throughout the period it is in my custody or control. I will be responsible for any damage caused to the motorcycle by failure to observe and check at daily intervals the level of engine oil and other lubricants, brake fluid (water and antifreeze if appropriate) and also tyre pressures. **I will be responsible for the cost of repairing punctures or replacement of damaged tyres due to punctures or wear, and for recovery/collection charges resulting from punctured tyres or from running out of petrol whilst test riding or any accident or damage occurring during the period it is in my custody or control, resulting in Woods having to recover the vehicle.**

F. The vehicle is to be ridden **by the authorised rider named below ONLY and is insured Third Party only for that person,** and the motorcycle will **only** be used for **social, domestic and pleasure purposes** and **not** for my own business purposes. It will not be used for track days or any other form of racing, **nor permitting any other person to use the vehicle at any time or under any circumstances.**

G. I will indemnify the dealer against any fixed penalty or other fines/costs incurred with respect to the motorcycle during the loan period.

H. **I will accept full responsibility for personal injuries sustained by any person whilst riding the motorcycle and for any injury, loss or damage whilst the motorcycle is in my control. I will not claim for any injuries caused by neglect in my control of the vehicle or for a pillion passenger.**

I. I am over 18 years of age and I have had a full motorcycle license for over one year. I have not been convicted or have pending convictions for endorsements codes: **AC, BA, CD40-60-70-71, DD, DR, IN, LC30-50, MS40-90, NE99, TT99, XX99, UT** (any pending endorsements must be disclosed). I am not, **nor have I been disqualified for more than 6 months in the previous 3 years or a period of 3 months during the past year. I have not had any accidents or theft claims through fault of my own or any other party in the past 3 years.** I have not been convicted, nor are there any pending convictions against me for fraud involving any vehicles or an insurance company. I have not had any more than **two fixed penalty speeding offences** on my licence in the last two years. I am not taking or under the influence of any prescription medication, drugs or alcohol that may affect my ability to drive or control this vehicle.

If you do not agree with or cannot meet the conditions laid out in B, C, D, E, F, G, H and I, please do not continue to fill in this form, as we will decline the offer of any demonstration, courtesy or loan vehicle.

OR

If you agree with our terms and conditions please continue to complete the following fields below and sign for the conditions set out below. **I permit Woods Motorcycles to retain the offered vehicle and licence and passport and any security and keys as security until any claim against me is settled in full.** I absolve Woods Motorcycles from the responsibility of meeting any claims resulting from an accident or injury sustained, or from any claims from a road traffic offence or third party vehicle whilst the vehicle is in my possession, for whatever reason. I have read and understand the above terms and conditions and I agree to be bound by them. I have read paragraphs B, C, D, E, F, G, H and I, **and I am fully aware of, and understand the conditions set out by Woods Motorcycles. A copy of this declaration is available on request and available on our website www.woodsmotorcycles.co.uk.** I am also fully aware and conversant of the controls and I am competent to ride the motorcycle, which I am taking for demonstration/loan and have the correct category on my license.

I have been offered the option of comprehensive insurance at a cost of £59 per day (as in para A) which I have chosen not to take.

SERVICE LOAN MOTORCYCLE TERMS & CONDITION CHANGES 1ST JANUARY 2021

From the 1st January 2021 all service loan machines required by customers are provided **at a cost of £6.90+VAT (£8.28) per day of loan, this includes Third Party only insurance and does not cover any damage to, or theft of, the machine.** This covers the general wear and tear and new vehicle devaluation (and is not a hire charge).

Upgrades to comprehensive insurance cover are charged at £59.00 per 48 hour period (£975 excess applies). This total charge will be added to your final invoice.

PLEASE TICK YOUR INSURANCE COVER CHOICE BELOW (SELECT ONE ONLY):

- THIRD PARTY COVER (Free)** – I agree to adhere to the terms and conditions set out in B, C, D, E, F, G, H, I (see overleaf).
- FULLY COMP COVER (£59.00 per 48 hour period, excess £975)** - I agree to pay the additional premium for the service loan machine.

THE USE OF DEMONSTRATION VEHICLES FROM 1ST JANUARY 2021

Previous customers will be exempt from the demonstration charges.

The use of some demonstrators will also carry a demonstration loan charge for 2021.

Some Triumph & Ducati motorcycles are subject to the £59 fully comprehensive insurance charge per 2 hour session.

Used motorcycles will need to be pre-booked 48 hours before the time of test ride to allow us to carry out safety checks on the motorcycle.

Used motorcycles will **have a two hour limit**. There are no charges to be levied at the current time.

Insurance packages (demonstrators) – **Comprehensive insurance** is available for £59 with an excess of £975 (terms and conditions apply overleaf). **Third Party insurance only** cover is included in the demonstration charge price (please see terms and conditions overleaf). Any vehicles left for security prior to demonstration must have a trade value exceeding £2000+

Any machine that is returned late from a test ride will incur a charge of £50+VAT per hour, no exceptions.

Unfortunately these charges are to deter the occurrence of "joy riding" our new machines that has started to exist and escalate over the last few years and not returning the vehicle at the agreed time. **In our own dealership and many others, genuine ladies and gents who want to test ride our vehicles are more than welcome and of course can test ride more than one machine during the time allowed.**
